From the Small Watershed Community Committee SWCC Milestones

Three GPCA members attended the Maryland Water Monitoring Conference on Dec 16, 2019, where there was a lot of talk about the importance of citizen science and volunteer water monitoring.

Volunteer water quality monitoring is key for up-to-date knowledge about changing water health and conditions, as well as to increase community engagement and investment in streams. Stream monitoring efforts are necessary for prioritization of conservation and restoration efforts.

A survey of citizen water quality monitoring groups, done by the Virginia Dept of Environmental Quality, found that volunteers save the government huge amounts of money. They estimated that over \$3.25 million is spent each year by volunteers in Virginia through volunteered time, out-of-pocket expenses, and analysis costs. Thus, it pays for local governments to provide grants to citizens doing monitoring.

Major water quality concerns mentioned during the conference are microplastics, estrogen disruptors, personal care product contaminants, nitrogen from agriculture, road salt runoff, and phosphates from car wash runoff.

There are many adverse impacts to surface and groundwater from road deicing salts. Many streams in Baltimore County are considered "impaired by elevated chloride", according to studies done by the Maryland Geological Survey. Median chloride concentrations groundwater in the Maryland Piedmont have risen from 6 to 202 mg/L in 40+ years. Salinity impacts fish and plants and causes the leaching of metals. Groundwater can serve as a year-round reservoir for chloride. Chloride corrodes pipes, the walls of pipes, and releases thinning

radionucleotides from geology into ground water, causing increased radon emissions.

2019 membership roundup: The 2019 membership goal was an ambitious one - 40% of the approximately 1,600 households within the GPCA boundaries as voting members. We ended the year with 13% of the households paying dues and therefore voting members. The 2019 member percentage is in line with the 2018 percentage but it would be great to have more active members in a CZMP year. Good news is that there were 27 new members in 2019 compared to just 7 in 2018. Welcome!

2019 Preliminary \$ and Cents: The preliminary 2019 bottom line is an operating deficit of (\$265) offset by \$880 contributed by 16 members in addition to their 2019 dues. That puts us in the black by \$618. GPCA has been awarded grants and those monies were used to purchase promotional banners and SWCC supplies. The net grant proceeds are not included in the \$618 noted above.

2020 Membership Campaign: February or March newsletter will include a letter highlighting the 2019 GPCA accomplishments as well as a request to join or renew your GPCA 2020 membership. Unless a household paid twice in 2019 (or prepaid their 2020 dues) the dues checks were considered 2019 paid members regardless of what month they were received. membership drive starts the voting household membership numbers at zero. An envelope will be included in the February newsletter as a convenience to mail in your 2020 dues. At the moment GPCA cannot accept payment by PayPal or similar applications. Remember the 2020 CZMP census will need input from GPCA only paid memberships can vote.
